ORDER

- (3) To review the existing guidelines in terms of Care & Support services based on technical update, evidence based best practices and emerging needs of the programme;
- (4) To assist in formulation of guidelines, protocols / tools for M&E framework including assessment process for Care & Support services under the programme;
- (5) To share and review the programmatic update/challenges experienced in the field of implementing Care & Support services under the programme;
- (6) Any other issues related to Care & Support for PLHA.

The TRG will meet atleast once a year or as and when required.

The expenditure on account of functioning of TRG will be regulated in accordance with the instructions issued from time to time and met out of the funds provided by National AIDS Control Organisation, Ministry of Health and Family Welfare, Government of India.
